

## Privacy Policy

Welcome to the Privacy Policy for **Hunter Gatherings** (I) I operate the website [www.hunter-gatherings.com](http://www.hunter-gatherings.com) (the "Site").

I am committed to protecting and respecting your privacy. This policy explains how we collect, use, process, and protect your personal data when you visit my website, enquire about our services, or commission me to create your wedding stationery.

For the purposes of the UK General Data Protection Regulation (UK GDPR), the data controller is **Hunter Gatherings**, based in Bitton, UK.

### 1. Information I Collect About You

Because wedding stationery is highly customized, we collect specific personal data to fulfill your orders. This may include:

- **Identity & Contact Data:** Your name, partner's name, email address, phone number, and billing/delivery addresses.
- **Wedding & Event Details:** Wedding dates, venue locations, timings, and any personal stories you share with us to inspire your custom watercolour designs.
- **Guest Data:** Guest names, dietary requirements (for menus), and home addresses provided by you for invitation printing and calligraphy services.
- **Technical & Usage Data:** Your IP address, browser type, and information about how you use my website (collected via cookies).

### 2. How I Collect Your Data

I collect data using three primary methods:

- **Direct Interaction:** When you fill out an enquiry form on my Site, email us, book a design consultation, or register for a creative craft party.
- **Client Uploads:** When you provide guest lists, spreadsheets, or wording documents for your stationery suites.
- **Automated Technologies:** As you interact with my website, I may automatically collect technical data using cookies and standard website analytics tools.

### 3. How I Use Your Personal Data

I will only use your personal data when the law allows us to. Most commonly, I use your data to:

- Communicate with you and provide custom quotes.
- Fulfill our contract with you (designing, printing, and delivering your physical wedding stationery).
- Process payments securely via any third-party payment processors.
- Send you marketing communications or updates about our creative workshops, *only* if you have explicitly opted in to receive them.

**A Note on Guest Data:** I treat your guests' personal information with the utmost confidentiality. I *only* use guest lists to print your invitations, place cards, envelope calligraphy, or seating charts. This data is never used for marketing purposes.

#### 4. Data Sharing and Third Parties

I do not sell your data. To fulfill your order, we may share your information with trusted third-party service providers, including:

- **Professional Printing Partners:** To physically print your custom invitation suites or large-scale venue signage.
- **Couriers & Postal Services:** (e.g., Royal Mail, DPD) To deliver your physical stationery to your home.
- **Digital Tools:** Secure software platforms used to run my business, including website hosts, email providers, invoice/CRM software, and payment processors (e.g., Stripe, PayPal).

I require all third parties to respect the security of your personal data and treat it in accordance with the law.

#### 5. Data Retention

I will only retain your personal data for as long as necessary to fulfill the purposes we collected it for, including satisfying any legal, accounting, or reporting requirements.

- **Guest Lists & Seating Charts:** To protect your family and friends, all guest address lists and wording spreadsheets are permanently deleted from our local systems after **3 months** following the delivery of your final wedding stationery order.
- **Design Artwork:** I retain your original digital watercolour designs indefinitely so I can print additional pieces for you or feature them in my design portfolio (names and private details can be blurred upon request).

#### 6. Your Legal Rights

Under the UK GDPR, you have the right to:

- Request access to the personal data we hold about you.
- Request correction or erasure of your personal data.
- Object to or restrict the processing of your personal data.
- Withdraw your consent to marketing communications at any time.
